
1 - ANALYSIS OF BRAZILIAN EXPORTS OF HIDES AND SKINS

FEBRUARY 2020

The Hides and Skins Exports released by SECEX (Foreign Trade Secretariat), for the month of February 2020, registered the amount of US\$ 98.1 million, down 11.6% year-on-year, when total exports were US\$ 110.9 million, however higher 20.0% compared to January, when amount was US\$ 81.7 million.

Considering exports in square meters, during February were shipped 16.1 million, down 2.1% year-on-year, however higher 10.0% than January, when total was 14.6 million.


Below is the profile of accumulated exports of 2020:



These are the variations of the Brazilian exports of bovine leather during two months of 2020, year-on-year:

- Salted hides down 51.3% in value, but higher 13.8% in weight;
- Wet Blue declined 34.2% in value and 18.5% in area;
- Split WB higher 20.6% in value and 23.2% in area;
- Crust was higher 9.3% in value and 20.4% in area;
- Finished leather lower 8.7% in value, but higher 3.9% in area.

Below are the 2020 destinations:




These are 2020 highlights for the three main destinations for Brazilian leather:

- China, with share of 25.7% in value and 33.4% in area, falling 6.7% in traded area (+1.8% in January) and also -11.6% in value (-9.3%);
- US, with share of 19.8% in value and 10.8% in area, has increased 15.9% in area (+2.5%) and 3.1% in value (-10.6%);
- Italy, with share of 15.0% in value and 18.9% in area, has reduction of 9.2% in traded area (-9.8%), and also down 27.6% considering value (-31.7%).

Looking at performance of the TOP3 markets, only the US shows improvements in imported volumes and values. China worsened its performance a lot compared to January, and Italy, despite the small improvement, still presents important falls in both aspects.

As an analysis of other countries considered important players in the leather trade, we highlight the following: Vietnam, returning to 4th place in the ranking (5.4% share of value), shows now increase of 25.1% in area (-24.5% in January); Mexico, with share of 4.8%, is keeping significant growth of 92.0% in area and 67.8% in value; Germany, falling in the ranking and now with share of 4.7%, shows drop of 19.5% (+1.1%) in value and 3.8% in area (+22.1%); finally Hong Kong, with share of 4.6% in value, continues with significant increase in area of 85.1% (+168.6%), but now decrease of value of 17.2% (+8.3%).

Some highlights considering exporting states:

- Among the ten states with largest exports in the country, only Minas Gerais continues showing a recovery in value, now with +15.2%. Considering traded area, performance has improved a lot and now six states show growths, with the highest percentages being: Bahia (+44.6%), Pará (+24.5%), and Minas Gerais (+14.9%);
- Still in the top ten, largest drops in value were: Ceará, with -37.2% (previous -57.6%); Goiás, with -24.0% (-10.4%); Santa Catarina, with -14.0% (-15.7%); Mato Grosso do Sul, with -14.6% (-32.8%); and Rio Grande do Sul, with -13.5% (-13.4%);
- Despite fall in value and area, Rio Grande do Sul remains leader in shipments, with share of 26.2% and 20.9%, respectively. Paraná continues in second considering value, with share of 16.0%, and also in volume, with 17.9%; São Paulo resumes the third position in the state of Goiás, showing share of 14.7% in value, but continues in fourth in area, with 12.8%; therefore, Goiás is now the fourth in value and third in area.
- It is also important to highlight the growth in value of Rio de Janeiro, which is now in the 12th position, with an increase of 53.1%, but still with a drop of 77.9% in area, apparently changing the export profile.

The scenario continues, with the relative stability of the traded area (-1.5%) and a decline in value (-14.0%). February showed a reaction of the average values and prices of Wet Blue, Crust, and Finished leather. The daily average of the export value was much higher than January (US\$ 5.4 million / day against US\$ 3.7 million), with the total not being more positive due to the few working days in the month (18 days against 22 of January). Finished leather maintains its majority share in the total exported values, with 59.3%, even approaching Wet Blue again in area, reaching 45.2% against 46.1%. the instability of the world economic scenario still does not appear in the results of exports for the two months, but it causes a lot of insecurity and concern among all companies, which until now are favoring a devalued Real, taking the opportunity to effect more business and expand markets.



Area (sqm) * (Full grain and Split)


