
## 1 - ANALYSIS OF BRAZILIAN EXPORTS OF HIDES AND SKINS

#### **MARCH 2021**

The Hides and Skins Exports released by SECEX (Foreign Trade Secretariat) of the Ministry of Economy, for the month of March 2021, amounted to US\$ 111.9 million, an increase of 15.4% year-on-year, when US\$ 97.0 million worth was exported. Also, reflects a figure 2.2% higher than February, when total was US\$ 109.5 million.

Considering exports in square meters, during March were shipped 15.1 million, 4.4% lower year-on-year, and also down 3.6% compared to the previous month, when total was 15.7 million.

Below is the profile of 2021's bovine exports:




These are the variations of the Brazilian exports of bovine leather during 1Q 2021, year-on-year:

- Salted hides higher 76.8% (previous +134.7%) in value, and also +24.5% (previous +40.4%) in weight;
- Wet Blue increasing 44.5% (+46.7%) in value, but -15.2% (-10.7%) in area;
- Split WB now higher 10.9% (+2.8%) in value and 10.5% (+7.4%) in area;
- Crust increasing 12.1% (+4.7%) in value and also 3.9% (+0.2%) in area;
- Finished leather up 5.5% (+5.5%) in value, and also +1.3% (+3.7%) in area.





Below are the 2021 destinations:



Some highlights of results for 1Q 2021 of the three main destinations for Brazilian leather:

- China (without HK) has now share of 27.8% (previous 27.2%) in value and 32.3% (previous 32.8%) in area, with a monetary increase of 36.1% (+22.2%), and also up 3.7% (-2.5%) in volume;
  - Italy, with share of 18.2% (20.9%) in value and 18.6% (21.2%) in area, with an increase of 36.5% (+61.3%) in value, but down 5.2% (+11.4%) in volume;
- United States, with a share of 14.0% (14.4%) in value and 8.6% (8.7%) in area, shows a monetary drop of 22.7% (-16.4%) and also a decrease of 26.0% (-20.1%) in volume.

The impact of new restrictions in Europe is already reflected in Italy, which now has a reduction in volume over the same period in 2020. In addition, the USA exacerbates declines in both value and volume. China continues to improve the Brazilian leather purchase indexes, in both aspects. If we add Hong Kong, China will have almost twice the volume share over Italy, which is the second placed in the ranking.

As an analysis of other countries considered important players for the Brazilian leather, we highlight the following: Vietnam, in 4<sup>th</sup> place in the ranking (improve share in value from 6.9% to 7.2%), had an increase of 32.5% (+47.2%) in value, and also 6.4% (+13.5%) in volume; Germany, improving share in value from 4.0% to 4.1%, shows now an increase of 2.9% (-1.7%) in value, but still down 4.0% (-7.0%) in area; and Thailand, keeping 6th place, with value growth of 15.4% (+46.7%), and also in area of 13.1% (+46.6%). Among the TOP30 destinations, the highest growth of 1Q is now with Japan, with +840.3% in value and +929.1% in volume, followed by Spain, with +389.1% in value and +653.1% in area.


Some highlights considering exporting states:

- Among the TOP10, now drops in value are registered in Santa Catarina and Pará, compared to 1Q last year, with -1.9% and -1.1%, respectively;
- Despite these declines signaling practically stability, there were worrying reductions and, in more states, when considered the traded area, being: Pará (-41.7%), Mato Grosso do Sul (-31.1%), Bahia (-14.0%), Paraná (-7.0%), and Ceará (-4.2%).
- Still among the TOP10 and comparatively to the same quarter of 2020, the state with the greatest growth in value and volume is Minas Gerais, with +42.7% and +36.2%, respectively;
- Among all states, highest performances in value were in Rio Grande do Norte (+158.5%), and Piauí (+157.9%). Considering volume, was Piauí, with +332.3%. Rio Grande do Norte does not present values in area because it is about exports salted hides or parings. The same occurs in Amapá;
- Among the TOP4, São Paulo takes back second place from Paraná considering values, now showing a share of 15.0%, where Paraná has a 14.3% share. In volume, Paraná continues in second, with 15.3%, and São Paulo in third, with 14.6%. Goiás is fourth in terms of value (13.9% share) and also in area (13.7% share). Rio Grande do Sul maintains the leadership in terms of value (28.8%) and volume (27.6%), which represent almost twice the number of second places.

Despite the growth in value this month, the concern about the quantities shipped remains, worsening the fall registered in February. In March, there was an expressive growth of 15.4% over March 2020, and also 2.2% over February. This percentage of 15.4% is also the cumulative increase in the 1Q of the year, over the same period in 2020. However, the decrease in traded area over the equivalent month of 2020, which in February was -2.4%, now worsened to -4.4%, showing an accumulated value of -2.0% in the quarter. Another information that worries is considering the daily average of the exported volume, which was 1.49 thousand tons, against 1.70 thousand tons in March / 2020, a decrease of 12.4%.

About markets, practically all Asian countries show strength and present increases in value and volume in the consumption of Brazilian leather, led as usual by China, followed by Vietnam, Thailand and South Korea. The exception occurs in India, where the pandemic, which had already been causing damage, started to worsen in recent days, with a greater number of cases and deaths, in addition to new environmental problems faced by tanneries in the Kanpur region. The reflection is a drop of 31.7% in value and 63.6% in volume in this market.

The expectation starts to be on the results starting in April, the month in which the sector's exports started to fall in 2020, reaching the lowest levels in June, with the worst result presented since April 1999. Recent price increases of the main raw material, combined with other important costs, such as transportation and chemical products, may end up reflecting in declines in the volumes sold by Brazilian tanneries, representing even greater challenges in front of a sector still looking for a recovery.




