1 - ANALYSIS OF BRAZILIAN EXPORTS OF HIDES AND SKINS

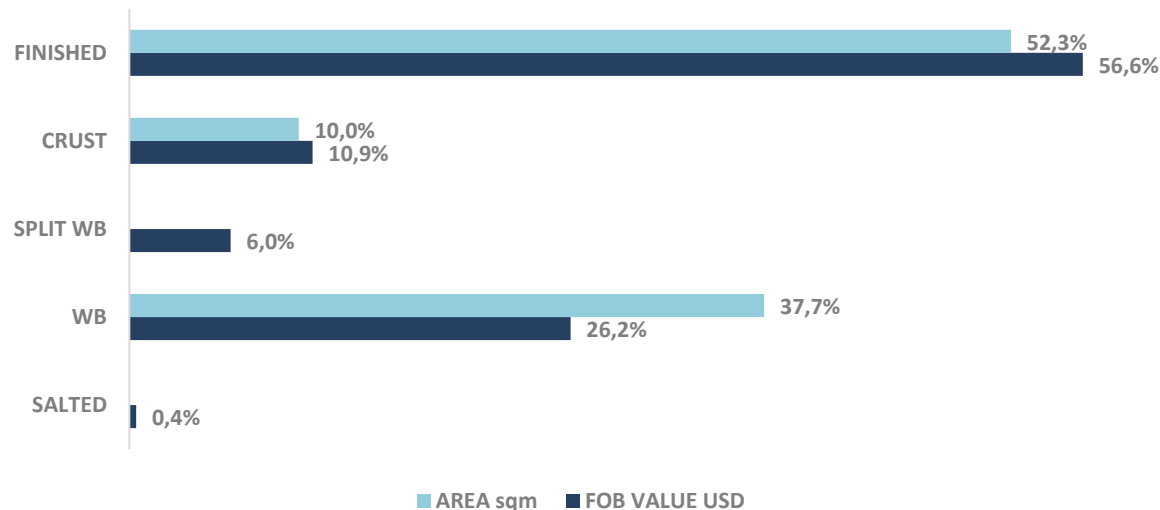
NOVEMBER 2021

The Hides and Skins Exports released by SECEX (Foreign Trade Secretariat) of the Ministry of Economy, referring to the month of November 2021, registered the value of US\$ 100.8 million, which means a decrease of 1.2% compared to the same month last year, when US\$ 102.0 million were exported. The value was also 31.6% below the previous month, when exports totaled US\$ 147.3 million.

As for the total exported in square meters, 10.5 million were shipped in November, a 39.6% reduction over the same month in 2020, and 33.7% less than in October, when the total was 15.9 million of sqm.

The period from January to November ended with a total of US\$ 1.29 billion, 48.2% above the same period in 2020, and a 3.2% increase in traded area, with 159.6 million square meters.

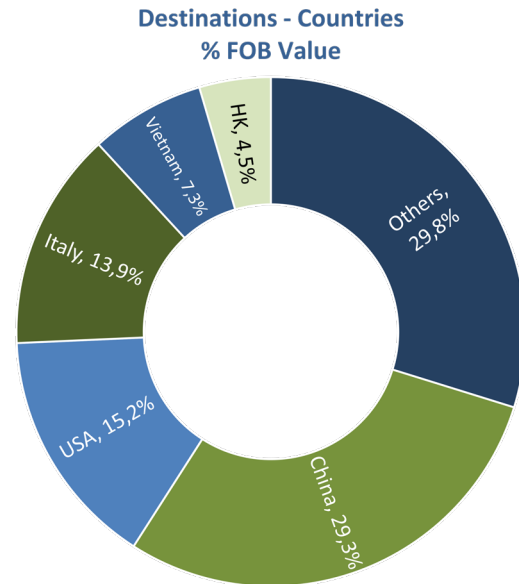
Below is the profile of 2021's bovine exports:



There are the following variations in Brazilian exports of bovine leather from January to November 2021, compared to the same period in 2020:

- Salted hides with an increase of 19.6% (previous +23.5%) in value, but a drop of 59.9% (previous -58.0%) in weight;
- Wet Blue growing 50.4% (+57.7%) in value, but falling 24.4% (-21.7%) in area;
- Split WB with an increase of 48.8% (+57.7%) in value and 23.5% (+31.7%) in area;
- Crust growing 58.3% (+64.7%) in value and 16.1% (+23.4%) in area;
- Finished with 45.7% (+51.7%) above in value, and +17.6% (+24.2%) in area.

Below are the main destinations for the period, considering traded area:

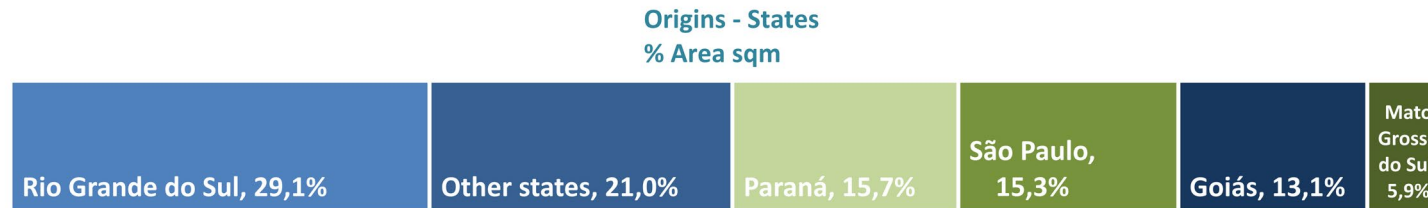


We highlight below the accumulated results for 2021 for the three main markets for Brazilian leather:

- China (without HK) with a share of 29.3% (before 29.8%) in value and 35.6% (before 36.0%) in area, with a monetary increase of 59.5% (+69 .6%) and +6.6% (+12.5%) in area;
- Italy, returning to 2nd place in the ranking, with a share of 15.2% (14.2%) in value and 15.8% (15.0%) in area, with growth of 39.4% (+40 .8%) in value, but still with a drop of 16.7% (-15.2%) in area;
- United States with a share of 13.9% (14.3%) in value, now with 8.7% (8.9%) in area, has a monetary increase of 16.8% (+24.8%) and now fall of 0.3% (+7.4%) in area.

As predicted last month, Italy regained the second position in the ranking of the biggest buyers of Brazilian leather, after a few months behind the United States. However, like the other two countries among the TOP3, the indexes worsen with the results of November, compared to the period up to October. Considering total shares, only Italy increased its share in value and volume, while the United States and China had reductions.

Below is the share in volume of the states of the federation with relevant exports for the sector in 2021:



Regarding the states, we can highlight the following:

- Export values from the ten largest states still maintain double-digit growth, although some have reduced significantly and may reach stability by the end of the year, such as the cases of Bahia and Mato Grosso do Sul. The data of the most expressive growths are: Minas Gerais, with +118.1% (+128.8%), São Paulo, with +68.1% (+77.5%), Paraná, with +57.6% (+64.5%), Rio Grande do Sul, +56.3% (+63.8%) and Goiás, with +46.3% (+48.2%);
- Regarding the traded volume, we now have only four states with positive indexes in area, which are: Minas Gerais, with +66.9%, São Paulo, with +28.9%, Rio Grande do Sul, with +27.3% and Ceará, with +17.4%.

November exports registered the second worst month of the year in terms of values, and the lowest result in volumes, both in area and in weight. Historically, if we disregard the worst month of the pandemic for exports (June 2020, with 8.7 million sqm), and the month with a strong impact from the truck drivers' strike in the country (July 2018, with 9.9 million sqm), this November had the lowest volumes of hides and skins destined for the foreign market since July 2011, more than ten years ago.

As for the types of leather, there were drops in volumes at all stages, compared to the months of November 2020 and 2019. In terms of values, there was a certain stability in Wet Blue over November 2020, with +1.2 %, and an improvement in Crust, with +7.1%. If the month of December continues with this downward trend, we should close the year with declines in the area traded in Wet Blue and with indexes close to stability in Crust and Finished, despite the positive monetary indexes at all stages.

There is no doubt that the situation of the world leather industry cannot completely detach itself from the restrictions and impacts of the pandemic, even if such effects are less devastating than in other sectors. Import markets continue with reduced purchases, which, together with increases in hides offers in the world, have been impacting global leather prices since August. -

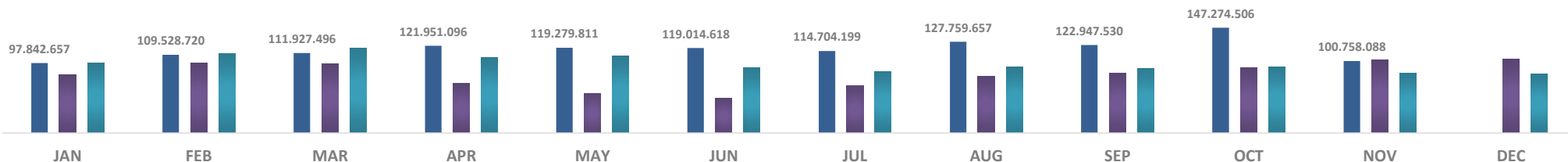

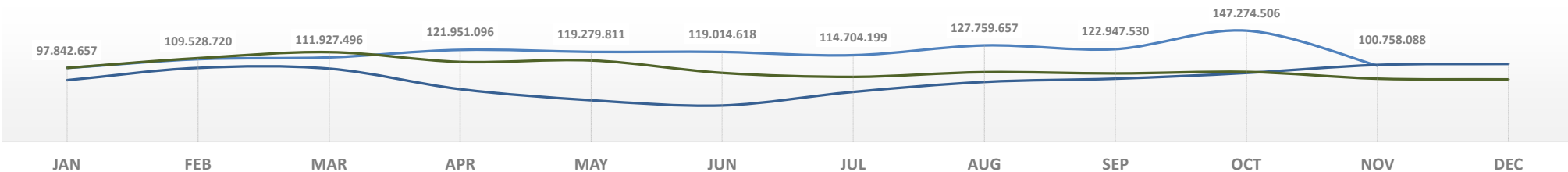

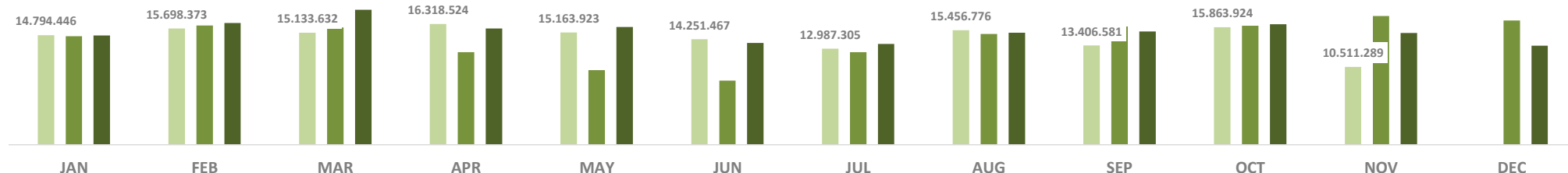
BRAZILIAN EXPORTS OF HIDES AND SKINS

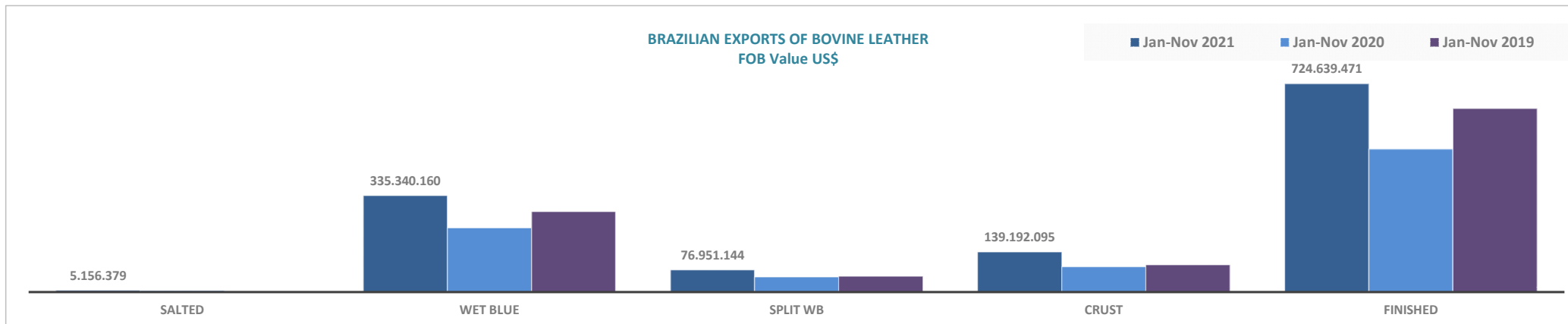
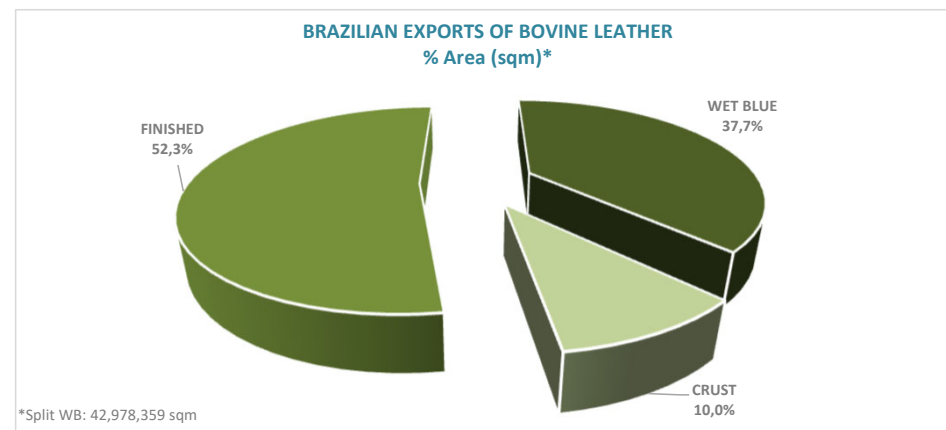
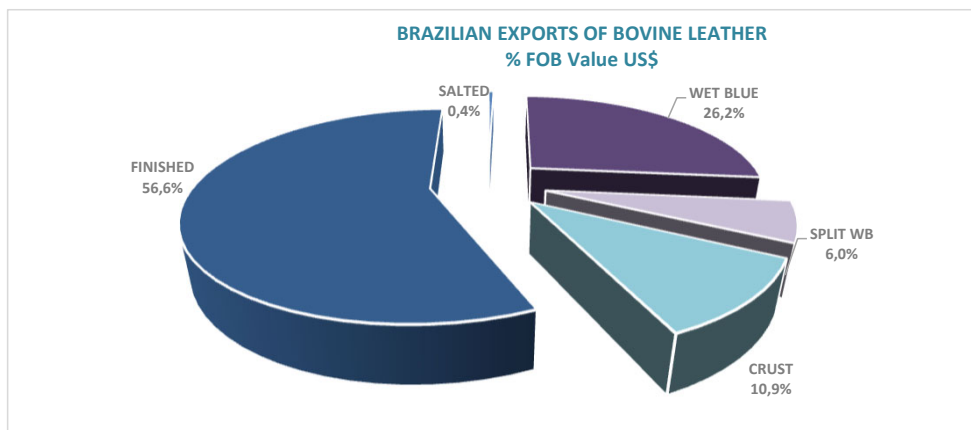
