1 - ANALYSIS OF BRAZILIAN EXPORTS OF HIDES AND SKINS


OCTOBER 2021

The Hides and Skins Exports released by SECEX (Foreign Trade Secretariat) of the Ministry of Economy, for the month of October 2021, amounted to US\$ 147.2 million, an increase of 61.5% year-on-year, when US\$ 91.2 million worth was exported. The value is also 19.8% higher than the previous month, when exports totaled US\$ 122.9 million.

Considering exports in square meters, during October were shipped 15.9 million, 1.2% lower year-on-year, however up 18.3% compared to the previous month, when total was 13.4 million.

The period from January to October ended with a total of US\$ 1.19 billion, 54.7% above the same period in 2020, and an increase of 8.6% in traded area, with 149.1 million square meters.


Below is the profile of 2021's bovine exports:



These are the variations of the Brazilian exports of bovine leather during total period of 2021, year-on-year:

- Salted hides with an increase of 23.5% (previously +33.5%) in value, but down 58.0% (previously -56.2%) in weight;
- Wet Blue increasing 57.7% (+59.0%) in value, but lower 21.7% (-20.8%) in area;
- Split WB with an increase of 57.7% (+55.5%) in value and 31.7% (+31.8%) in area;
- Crust up 64.7% (+56.6%) in value and 23.4% (+21.5%) in area;
- Finished with 51.7% (+51.1%) above in value, and +24.2% (+27.1%) in area.

Below are the main destinations for the period, considering traded area:



We highlight below the accumulated results for 2021 for the three main markets for Brazilian leather:

- China (without HK) now with a share of 29.8% (previously 30.1%) in value and maintaining 36.0% (previously 36.0%) in area, with a monetary increase of 69.6% (+72.2%) and +12.5% (+15.6%) in area.
- United States with a share of 14.3% (14.5%) in value, now with 8.9% (9.0%) in area, has a monetary increase of 24.8% (+23.4%) and of 7.4% (+7.7%) in area.
- Italy, with a share of 14.2% (13.8%) in value and 15.0% (14.9%) in area, with growth of 40.8% (+39.6%) in value, however with a decrease of 15.2% (-13.7%) in area.

Italy regained its share with the October result, now approaching again the United States in value, and may surpass in the coming months and retake the second position in the ranking of the main buyers of Brazilian leather. China, like the United States, remains with a stable share in terms of value and volume, but with indexes that represent more than double the other two main destinations. The TOP3 monetary increases remain at high levels, while volumes approach 2020 for the US and China, with Italy further worsening its result.

Regarding the states, we can highlight the following:

- Export values from the ten largest states maintain double-digit growth, including Minas Gerais more than doubled its result. The highest percentages are from Minas Gerais, with +128.8% (previously +127.6%), São Paulo, with +77.5% (+74.7%), Paraná, with +64.5% (+68.0%), Rio Grande do Sul, +63.8% (+60.3%) and Ceará, with +53.0% (+54.4%).

- Considering the traded volume, the same three states of the previous period remain with negative indexes both in weight and in area, considering only the TOP10: Pará, with -39.4% (-44.9%) in area and -39.7% (-44.8%) by weight; Mato Grosso do Sul, with a decrease of 34.7% (-33.4%) and in weight of -41.2% (-39.7%); and Bahia, with -11.8% (-12.7%) in area and -10.6% (-14.5%) in weight. If we only consider weight, three other states show decreases: Goiás, Paraná and Santa Catarina.

The month of October registered the highest value exported since March 2018. In addition to +61.5% compared to October 2020, it also grew 59.0% over October 2019. Considering volumes, September had registered the biggest drop in weight and area, compared year by year, but October registered the second highest value exported in area this year, only losing to April.

Despite this, we have many records of difficulties in establishing new business, where the main customer, China, continues to increase circulation and production restrictions, canceling in-person events and maintaining quarantines, which makes life even more difficult for exporters. Added to this, the difficulties in the prices of raw materials, chemical inputs and logistical availability continue.

As for the types of leather, we must highlight the strong increases in the month in Finished and Crust exports, with growth over the same months in 2020 and 2019. In Finished leather, it was the biggest increase in value of the year, when compared to the same month of 2019, and the second largest increase in volume. Crust, on the other hand, recorded the biggest increase in value over the same month in 2020, and the second largest increase in the year over 2019. Wet Blue leather kept the path of recent months: important growth in value over the same month of previous years but strong falls in volumes. -






BRAZILIAN EXPORTS OF HIDES AND SKINS




